
- It is mandatory for the College to submit Affidavit in the prescribed format as per Academic Council's Resolution No. 229/2013 (Format attached).
- Uploading of eligibility data within three months from the date of admission of first year students.
- Colleges are required to carryout Permanent approval process of the Teachers who have been granted temporary approval upto 31st July 2019.
- To update Academic Online Teacher's Database of all teachers. On monthly basis review of availability of teachers shall be taken at College level & it shall be kept updated.
- Adequate facilities regarding Hostel and Library to be provided to the students.
- You are requested to comply with the above mentioned deficiencies within a stipulated time without fail and submit compliance report.
- Kindly note the above and do the needful scrupulously.

Important Note:

- Although the Continuation / Extension of Affiliation is granted to your College for the Academic Year 2019-2020, you are not allowed to admit students for First Year BHMS Course without receipt of permission from Central Council of Homoeopathy, New Delhi and Department of AYUSH, New Delhi.
- The Dean / Principal of the College is hereby instructed to submit letter of permission from Central Council of Homoeopathy, New Delhi and Department of AYUSH, New Delhi to the Admission Regulating Authority, Mumbai.
- In case of any irregular admissions, University shall not be responsible for any academic or pecuniary loss or damages of the concerned.
- The admissions shall be done only through the Competent admitting Authorities.
